- Purchaser required to post signs on USFS roads alerting recreationalists of thinning activities.
- Snowmobile Restrictions: Hauling is prohibited on the Snowmobile Trails on Federal Holidays, weekends starting noon on Friday through midnight Sunday, and between Christmas Day and New Year's Day. <u>T-8110</u>: Maintenance Blading/Grading is keeping an aggregate surfaced Roadbed in a condition to facilitate traffic and provide proper drainage. It includes maintaining the Crown, Inslope or Outslope of the Traveled Way, Turnouts, and Shoulder; repairing Berms; blending approach road intersections; and cleaning Drainage Dips and Lead-off Ditches.

<u>T-8420</u>: This work includes removal of brush, trees and other vegetative growth from within the clearing limits. This may include brush mowing of shoulders to prevent larger growth which would inhibit travel in the future.
