NR 668.02(9) Wis. Adm. Code), unless the waste will be treated and monitored for all underlying hazardous constituents. If all underlying hazardous constituents will be treated and monitored, there is no requirement to list any of the underlying hazardous constituents on the notice. The notification and certification must be updated if the process or operation generating the waste changes and/or if the subtitle D facility receiving the waste changes. Note if a subtitle D landfill is receiving the treatment residues (a non-hazardous waste) you are not required to send to the subtitle D landfill any LDR notification and certification forms, even the subtitle D landfill must treat the UHCs in the treatment residues prior to land disposal. The LDR certification form must include the following information: 1. LDR certification form must be signed by an authorized representative and must state the language found in s.
