- Muab cov koob thiab cov koob chob ntsuas ntshav (lancets) pov rau hauv lub thoob seem txej (trash)
- Muab cov koob thiab cov koob chob ntsuas ntshav (lancets) tso rau hauv lub thoob ntim khoom koj mus nchuav dua tshiab (recycling containers)
- Nqa cov koob thiab cov koob chob ntsuas ntshav (lancets) mus rau ntawm qhov chaw khaws tshuaj

Cov kev phom sij ntawm cov khoom ntse hau uas siv tas lawm yog dab tsi?

Cov koob thiab cov koob chob ntsuas ntshav (lancets) uas siv tas lawm yuav chob tau cov neeg ua hauj lwm uas muab cov khoom qias pov tseg thaum muab cov ntawd pov tseg hauv lub thoob seem txej los yog thoob rau cov khoom rov qab koj mus nchuav dua tshiab, nqa mus rau ntawm qhov chaw khaws tshuaj, los yog yaug hauv lub qhov txhoj khawv (toilet). Tus neeg ua hauj lwm uas koob chob raug huam yuav yuav tsum tau mus soj ntsuam mob uas kim thiab txhawj txog qhov tias tsam tau kab mob xws li Kab Mob Siab thiab HIV. Tiam sis, yuav tiv thaiv tau cov kev raug mob los ntawm koob chob kom tsis txhob phom sij rau txoj kev noj qab haus huv. Muab cov koob ntse hau ntim thiab pov tseg kom nyab xeeb kom thiaj li tsis raug koj thiab lwm tus neeg.



Muab cov koob thiab cov koob chob ntsuas ntshav ntim kom nyab xeeb:

- Rov muab lub hau los khwb rau *koj* rab koob uas tsis siv lawm los yog nias cov hau koob rau.
- Muab cov khoom ntse hau tso rau ib lub thoob uas khov, tho qhov tsis tau uas muaj ib lub hau kaw rau kom khov.
- Lo ntawv kom zoo zoo rau lub thoob uas siv cov lus xws li “bio-hazard,” “khoom qias uas kis tau,” los yog “khoom ntse hau.”
- Thaum lub thoob puv lawm, muab lo rau thiab muab pov tseg kom nyab xeeb raws li ib txoj kev nram qab no.

Siv ib txoj kev muab pov tseg uas nyab xeeb no:

- Nqa lub thoob mus rau ntawm qhov chaw khaws cov khoom ntse hau uas tau rau npe cia. Mus rau ntawm **dnr.wi.gov** thiab tshawb nrhiav “**healthcare waste**” es nrhiav ib qho chaw nyob ze ntawm koj.
- Nug koj tus kws kho mob, chaw kho mob los yog lub tsev kho mob hauv zos seb koj nqa puas tau cov khoom ntse hau mus pov tseg ntawm lawv qhov chaw.
- Hu rau koj lub zos qhov chaw nqa tshuaj, qhov chaw pab pej xeem txoj kev noj qab haus huv, chaw xyuas txog khoom qias, los yog chaw xyuas cov kev kom kawm tau ntxiv txog lwm cov kev pov tseg hauv zos.
- Siv ib qho kev pab cuam xa cov khoom ntse hau rov qab.
