PERMIT

The above Tribal Member Permittee is hereby authorized and permitted to gather the following miscellaneous forest product - Boughs - subject to the conditions listed below:

A. Amount of product that may be gathered:

B. Location in which gathering is permitted (see attached map):

C. Conservation or Public Health or Safety Provisions:

1. Gathering may take place only in designated areas and only on designated trees.
2. Use of vehicles and equipment off of existing roads must be approved by the property manager prior to use.
3. No boughs may be taken within 100 feet of any public roads, rivers and lakes.
4. No boughs may be taken from the top 1/3 of any tree.
5. No axes may be used to cut boughs from the tree.
6. Boughs shall be cut in such a manner as to not kill or damage the tree.
7. All persons engaged in gathering miscellaneous forest products must be tribal members and possess a valid tribal identification card (except for immediate family members who may assist in the gathering when the permittee is present as long as the family members do not cut or uproot plants).
8. Further provisions:

D. This permit is valid from _____, 20____ to _____, 20____, and the gathering authorized under this permit may not be conducted outside of this period.

E. Standard Provisions:

1. The Tribal Member must possess this permit at all times while gathering or transporting the gathered miscellaneous forest product.
2. While gathering or transporting any miscellaneous forest product, this permit, any accompanying map and a tribal identification card must be presented by the permittee upon request by any Department representative.
3. The permittee assumes all responsibility to gather in designated area only and to assure that he/she is on Department property.
4. The Department assumes no responsibility for injuries to or caused by the permittee by issuance of this permit.
5. All roads and trails shall be kept open at all times and may not be damaged.
6. No permittee may transfer this permit or allow the use thereof by any other person.
7. Existing regeneration and/or residual trees may not be damaged.
8. The permittee shall comply with all slash, fire, theft and litter laws. No gathering may be conducted during emergency forest fire bans under ch. NR 30, Wis. Adm. Code.
9. Violations of this permit or any conditions of gathering stated herein shall be determined by the Department and will result in the revocation of this permit. Violations may also subject the permittee to an assessment for any actual damage caused or prosecution for violation of s. NR 45.04 (use of Department property), Wis. Adm. Code , ss. 26.05 (timber theft) or 943.13 (trespass), Wis. Stats., or other applicable rules and statutes.
