Mulazim Nasir has retired after 31 years of service to the citizens of the state of Wisconsin.





Retirement Resolution

Mulazim Nasir retired from the Department of Natural Resources in August 2008 having provided over 31 years of honorable and valuable service in improving water quality in the state. Mulazim's career with the Department began in the Department's Municipal Wastewater Section following his graduation with a Masters Degree in Environmental Engineering from the City University of New York. Mulazim also had a Bachelor of Science Degree in Civil Engineering from the Engineering University, Lahore Pakistan.

Mulazim spent his entire career in the municipal wastewater program area and achieved distinction by developing expertise in technical subjects vital to the proper design and operation of wastewater treatment facilities. He conducted research and provided expert advice on aeration and pumping system designs. Mulazim took pride in the quality of his work and was known for his attention to detail and doing a thorough job in project reviews.

Mulazim worked primarily on projects located in the Department's Northeast Region and he earned the respect and gratitude of the regional wastewater staff who worked with him. If Mulazim reviewed the project, they knew the plans would be correct before the construction started and problems would be minimized. Mulazim's family even made a contribution to the Department. His daughter, Amber, worked as a LTE in the municipal wastewater program for a number of years. Following in her father's footsteps, Amber made a valuable contribution and became a good friend to all she worked with.

Mulazim was a valuable asset to the Department and the State of Wisconsin through his dedication, work, and expertise.
