RECOMMENDATION: Adopt retirement resolution for Eldene Furman



Retirement Resolution

Eldene (Deanie) Furman, Visitor Services Associate, Kettle Moraine State Forest – Southern Unit, retired on September 15, 2008, after 30 years of dedicated service to the people of Wisconsin. Deanie worked her entire career in the Parks and Recreation Program at the Kettle Moraine State Forest - Southern Unit in Eagle.

Deanie is a native of Milwaukee. After graduating from Custer High School, she worked for eight years at the Wisconsin Gas Company. In 1978 Deanie started her Department career working at the Kettle Moraine State Forest – Southern Unit as a typist. In September 1982, she was promoted from this limited term employee (LTE) position to a permanent position as a seasonal Clerical Assistant I. In 1984, her position was reclassified to a seasonal Program Assistant I. For nearly 16 years, Deanie worked as a seasonal employee for nine months of the year and as an LTE for the remaining three months. In 1998, her seasonal Program Assistant I position became a year-round full time position. In 2005, Deanie was reclassified to a Visitor Services Associate.

Throughout her career, Deanie used her extensive knowledge of Department rules, regulations and general information to assist Southern Unit visitors. Always striving to provide quality customer service at one of the most highly visited properties in the State, Deanie consistently met the demands of a heavy workload in a professional and efficient manner. In recognition of her outstanding customer service, Deanie was twice nominated by her supervisors for the Virginia Hart Award which recognizes exemplary performance and service to the citizens of the state.
