### ***Retirement Resolution***

Diane Parrish, Purchasing Agent in the Bureau of Finance, Madison, retired from the Wisconsin Department of Natural Resources on October 7, 2005. Diane retired with over 19 years of dedicated service to the citizens of the State of Wisconsin.

Diane began work with the State of Wisconsin Department of Health and Social Services on November 11, 1985 in the position of Data Entry Operator. On January 1, 1990 Diane transferred to the new Department of Corrections (part of the creation—no change in job) serving as Data Entry Operator and Program Assistant.

On July 6, 1997 Diane accepted a promotion to Purchasing Agent with the DNR, Bureau of Finance Central Office, Madison. On September 12, 1999 Diane transferred to the Department of Health and Family Services as a Purchasing Agent. On September 10, 2000 Diane returned to the DNR transferring to the South Central Region as a Purchasing Agent. Diane returned to the DNR Bureau of Finance Central Office by transfer on May 16, 2004 as a Purchasing Agent until her retirement on October 7, 2005.

Diane's long-term commitment to the State of Wisconsin in the area of data entry and purchasing operations has been greatly appreciated.

WHEREAS, Diane Parrish has served the people of the State of Wisconsin faithfully and well in the performance of duties and has thus earned the commendation due an exemplary public employee;
